Timings

After School Club operates from 3.15pm - 6.00pm (term time only) and current costs for each session are as follows:

Twilight Session 3:15pm until 4:30pm, £3.50

Late Session 4:30pm until 6:00pm, £4.50

Both Sessions 3:15pm until 6:00pm, £8

- **If you are late collecting your child, an extra charge of £1 will be incurred for every 5 minutes past 6:00pm.**

Admissions

- Only children attending Water Meadows Primary School are eligible to attend the Club.
- All places are subject to availability.
- An application and information form must be completed prior to the child's commencement at the club, containing information about the child's date of birth, address, health, contact details and persons who may collect child.
- Parents are made aware of how to access policies and procedures.
- Irregular users are welcomed provided there are spaces.
- All staff are made aware of the details of a new child.
- Children's attendance is recorded in a register on Arbor and parents must sign their children out when they leave.
- Copies of the Club policy are available upon request and on the school website. All parents must complete a registration form for each child attending the club and sign an agreement to adhere to Club policy.

Arrival and departure

- EYFS and KS1 children will be escorted by the class Teaching Assistant to the After School club.
- KS2 children will walk to the After School Club un-supervised.
- On arrival, all children are marked on the register.
- When a child is collected at the end of or during a session, they must be signed out by a parent/carer or named collector and the time recorded.
- The parent/carer or named collector must inform a member of staff that they are collecting and signing out a child.
- Parents/carers must ensure that any person who may collect their child is listed on the registration form and that it is kept fully up to date.



- The club reserves the right to withhold children if the person collecting the child is not on the registration form or the parents have not informed the school of the identity of the person collecting. A password system will be used for this purpose.

Daily routine

At 3.30pm all children gather in the hall area for a freshly prepared fruit snack and drink. Two Staff members will supervise the children at this time. After a snack the children will choose between Indoor 'free play' activities or Outside play (as long as it's dry).

3.45- 4.30pm: Planned activities take place as well as free play. This may include Craft activities facilitated by Play leaders (and free play available.) and Outdoor game facilitated by Play leaders (free play available)

4.35pm: Twilight club late snack.

5:20pm: Quiet time.

5.45pm: Staff and children tidy up

6.00pm: Last collection

Safeguarding

Behaviour

The Breakfast and After School Club follows the Behaviour and Anti-Bullying Policy of the School.



First aid

- All accidents will be recorded in Medical Tracker, and this will be accurately reported to the parents/carer upon collection.
- Accident records must give details of: time, date and nature of the accident; details of the child involved; type and location of the injury; what action was taken, and by whom.
- All incidents are dealt with by a qualified paediatric first aider. Parents of any child who become unwell during Club will be contacted immediately. If a child is sent home during school hours, Club leader will be informed of their absence.

Missing or uncollected children

Missing children:

In the event that a child goes missing, the following procedure will be undertaken:

Appropriate school staff will be informed of the missing child. Club Leader will search the inside of the building and delegate an outside search of the building to another member of staff. If the child remains missing, the emergency services will be contacted.

Uncollected children:

Parents will be contacted in the first instance by telephone. Emergency contacts will be contacted in the second instance. If these contacts are unavailable after approximately one hour, the police and Social Services will be informed.

Payment of fees

- If a parent is experiencing difficulty with payment of their fees, they should contact the school office staff as soon as possible.
- Payments must be made in advance, either termly, monthly, weekly or daily. There are no exceptions to this as it is essential that the club is self-financing.
- If you are paying daily, payment must be made in the morning of that day.
- Payments should be made via card payment or bank transfer.
- Childcare vouchers are also accepted.
